

# Southern Lehigh School District Board of School Directors Meeting

December 3, 2013

The first regular monthly meeting of the Board of School Directors of the School District of Southern Lehigh was held at 7:30 p.m. on the above date (December 3, 2013) at Southern Lehigh High School, Center Valley, PA.
