Mrs. Christman reported the following-

#### **OLD BUSINESS**

The Board continued the discussion on the findings of the Demographic Study and Life/Cost Analysis of Lower Milford and Hopewell Elementary Schools as presented at the Special Board meeting on August 28, 2013.

Mr. Dimmig extended an opportunity for public comments with instructions for speakers to sign-in and limit their comments to 5 minutes.

Ms. Lori Berta suggested keeping all three elementary schools open to provide flexibility and the option to push grades to other buildings.

Mr. Darin Jellison introduced himself as a Lower Milford parent and architect with experience in school projects. He suggested the option of grading to expand an addition to Lower Milford and an in-depth study of how other district buildings can be modified.

Ms. Kristen Jellison attended the August 28, 2013 board meeting and concerned about 50 minute bus ride times. She also reminded the Board that Lower Milford is the primary emergency shelter for Lower Milford Township.

Ms. Michelle Burns attended the August 28, 2013 board meeting and concerned about "possible board action" on today's agenda. She offered the suggestion that by keeping all three elementary schools open, there is flexibility to push grades to other buildings.

Ms. Diane Foster attended Southern Lehigh Schools and spoke in support of Lower Milford Elementary school and in favor of a smaller, neighborhood school.

Mr. Jim Reilly attended the August 28, 2013 board meeting and asked if full day kindergarten a consideration.

Ms. Amanda Robbins concerned about the length of bus ride times and consideration of routes.

Mr. Robert Burns spoke in favor of a smaller size school.

There was additional Board and audience discussion. Mr. Dimmig requested order from the audience and reminded all in attendance that no decisions have been made and that there would be no Board action at this meeting.

Mr. Bergey reviewed a map indicating student population.

There was discussion on the potential timeline for taking action based on the findings of the demographic study and life/cost analysis of Lower Milford and Hopewell Elementary schools.
