### **Facilities Committee**

- Hopewell Building Project-Geothermal well drilling has been a challenge for which options are being sought.
- District met with Mr. Thomas Beil, Upper Saucon Township to discuss Preston Lane Rotary options and schedule.
  - Target for project is the summer of 2017
  - Upper Saucon Township would like to present and seek approval at the January 11, 2016 school board meeting.
- Ball Shed needs to be replaced, but due to today's code requirements the anticipated cost of a salt/cinder shed is \$140,000 and the ball shed could exceed \$600,000.
  - Alternative options include installation of indoor batting cage in one
    of the gyms and the investigation of the cost of using a batting cage
    facility off campus.
